2 Privacy Officer

We are a small association, so we have less than 10 people to handle all our business transactions. We are therefore not obliged to appoint a privacy officer. You are welcome to contact the association's management (see 1).

3 Purposes of the processing and legal basis

Personal data is processed for the purpose of membership. We process from you:

- Name and address.

This information is mandatory for the implementation of your membership. If this information is incomplete, incorrect or if you deliberately withhold information, this may result in the termination of your membership (deletion according to § 4, para. 3 of the statutes). Further information is in principle voluntary. Since 25 May 2018, the legal basis for processing is Article 6 (1) (b) of the General Data Protection Regulation.

We distribute the following printed matter by e-mail:

- "MFG-Mitteilungen": Our information sheet contains in particular notices and information to our members, such as invitation to the general meeting, amendments to the articles of association, minutes and resolutions of general meetings.

The MFG-Mitteilungen are not advertising. To receive them, you must provide your e-mail address.

4 Processing in case of legitimate interest

No such processing (anything other than the fulfilment of your membership) will take place.

5 Receiver

The Managing Director as well as other authorised representatives of the Munich Society of Forest Science and Resource Management are able to access the data of all members.

5.1 Direct debit

For the collection of membership fees or other receivables, we will - if you have agreed in writing to direct debit - transmit your name and bank details to our bank in accordance with the requirements of SEPA.

6 Third country

We do not share your data with third countries.

7 Duration of storage

We store your data for as long as required by law.

8 Right to information, correction, deletion, restriction, data portability

You can obtain information about your data stored with us at any time. You can do this by e-mail or by writing to us (see 1). Should anything change, you can also correct your data in the same way. Please understand that we are legally obliged to store your data; therefore, we cannot offer you restriction or deletion.

9 Right to complain to the supervisory authority
